Sealed proposals will be received by the Office of the Oakland County Water Resources Commissioner, Oakland County, Michigan, Building 95 West, One Public Works Drive, Waterford, Michigan 48328-1907 ("Owner") for the construction of certain facilities and structures, including the following approximate quantities:

Construction of cleanout, grading, debris removal, and restoration of 3,210 lineal feet of existing open channel and the removal of approximately 830 cubic yards of sediment from an existing detention basin. The project includes streambank stabilization measures, tree removal, tree planting, removal and replacement of fencing, removal and replacement of landscape wall, and restoration.

Proposals will be received up to 3:00 P.M., local time, on the date set forth herein at which time all bids will be publicly opened and read.
