QUESTIONS

Per addendum 2:

- 1. For invasive species control
 - a. Invaded area mapped on concept plans in Utica was primarily Phragmites and reed canary grass, correct?
 - Yes
 - b. I cannot find another labeled area for control besides Utica, despite the fact the square footage doesn't measure out to 2ac (closer to 1), and significant amounts of knotweed are growing in sheets 8&9 near the SH Nature Center, and some reed canary & other invasive species along the bank where the river is closest to Utica Rd. south of Dodge Park...can you clarify primary target species, and confirm locations?
 - Phragmites and Reed Canary grass will be the primary target species. The significant location is in Utica. In fact there is a very large stand of reed canary grass under the power lines in Utica that will easily be 2 acres. Other areas are going to be small spots here and there.
 - c. SPECIAL PROVISION FOR INVASIVE SPECIES CONTROL indicates there is some brush (buckthorn?) control?
 - Brush control will be limited to buckthorn, honeysuckle and privet.

- d. Herbicide specs dictate "Rodeo", which depending on target species, will need repeat applications. May we include in proposal cost for management plan and 2 ac of treatment using this chemical, then if awarded make change orders based on field conditions and needs?
 - Invasive species control is a unit cost, so yes as needed spot treatments with rodeo or another approved herbicide is what we are looking for. Any herbicide that is used must be effective and used in accordance with State Laws.
- 2. Live stakes- I assume live stakes pay item is ONLY for LC1, & procurement of live stakes for other bioengineering practices is incidental to those items?
 - Ve
- 3. Are "wetland clay plug", "stabilized fill", as well as the apparent fill area with reed canary etc. along the bank where the river is closest to Utica Rd. south of Dodge Park live staking AND seeding areas?
 - Yes
- 4. Plugs in reviewing quotes in so far, at least one of the species aren't available from MNPPA nurseries this year, are substitutions permissible if agreed upon
 - Yes
- 5. Please confirm that BioDBlocks are acceptable for VRSS & Rolled Erosion blanket where possible.
