

ADVERTISEMENT FOR BIDS
2018-2019 WATER MAIN REPLACEMENT PROGRAM
CITY OF BLOOMFIELD HILLS
OAKLAND COUNTY, MICHIGAN

Sealed proposals for the construction of the 2018-2019 Water Main Replacement Program will be received by the City of Bloomfield Hills until 11:00 a.m., Local Time on Thursday, February 1, 2018, at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for, receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Description of Work

Approximately 2 miles of water main replacement, drainage improvements, pulverizing existing roads, edge drain installation, aggregate base installation, concrete curb and gutter, and miscellaneous items as indicated in the proposal. Project is located on 12 local streets located between Quarton Road, Lone Pine Road, Lahser Road, and Cranbrook Road.

Copies of Plans and Specifications and Proposal Forms shall be available on or after Thursday, January 11, 2018 at the offices of Hubbell, Roth & Clark, Inc., Consulting Engineers, 555 Hulet Drive, Bloomfield Hills, Michigan 48302-0360.

A mandatory pre-bid meeting will be held on Tuesday, January 23, 2018 at 10:00 a.m. at the City of Bloomfield Hills – 45 East Long Lake Road, Bloomfield Hills, MI 48304. Contractors are recommended to field walk or drive the project before the pre-bid meeting.

A non-refundable payment of One Hundred Forty Five (\$145.00) Dollars, **CHECK ONLY, payable to** “Hubbell, Roth & Clark, Inc.” will be required for each set of Drawings and Specifications. Drawings and Specifications can be shipped by U.P.S. ground for a shipping and handling charge of Forty (\$40.00) Dollars, CHECK ONLY, non-refundable, to Hubbell, Roth & Clark, Inc. The Bidder is advised that to submit a bid on this project, the Bidder must have purchased a set of Plans and Specifications from Hubbell, Roth & Clark, Inc.

Proposals submitted by Bidders who have been debarred, suspended, or made ineligible by any Federal Agency will be rejected.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.

Each bid proposal shall be submitted on the proposal forms provided and shall be accompanied by a certified check, cashier's check or bid bond, executed by the bidder and Surety Company, payable to the City of Bloomfield Hills in the amount of Five Percent (5%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary Contract with the City of

Bloomfield Hills. No bid may be withdrawn after scheduled closing time for receiving bids for at least Ninety (90) days.

The successful bidder will be required to furnish satisfactory Performance, Labor and Material, and Maintenance and Guarantee Bonds.

The City of Bloomfield Hills reserves the right to reject all bids and to waive irregularities in bidding.

No Proposal will be received unless made on blanks furnished and delivered to the City Clerk on or before 11 a.m., Local time, Thursday, February 1, 2018.
