Sealed proposals for the construction of the Riverside Bridge Deck Rehabilitation will be received by the Village of Beverly Hills until 11 a.m. Local Time on Tuesday, April 16, 2024, at which time and place all bids will be publicly opened and read.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for, receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

The Riverside Bridge Deck Rehabilitation Project in the Village of Beverly Hills shall consist of the following:

- 535 SF of Bridge Sidewalk Repair
- 200 SF of Bridge Deck Repair
- 85 LF of Pressure Injection
- 560 SY of Water Repellent Treatment, Penetrating
- 15 CFT of Bridge Railing Repair
- Grout Pocket Repairs
- 40 FT of Curb Replacement
- Removal of Overhanging Foliage
- 574 LB of Reinforcement, Steel, Epoxy Coated
- Removal of the Sandstone Inlay within the railing
