# **INVITATION FOR BIDS**

REVITALIZE BRILEY TOWNSHIP PARK ATLANTA, MICHIGAN

#### SITE IMPROVEMENT PACKAGE

The **TOWNSHIP OF BRILEY** will receive Bids for the **REVITALIZE BRILEY TOWNSHIP PARK - SITE IMPROVEMENT PACKAGE**, until 2:00PM, (Standard Time) on the Thursday, September 5, 2024, at 12423 JEROME STREET, ATLANTA, MICHIGAN, 49709, at which time and place all bids will be publicly opened and read aloud.

General Construction Lump Sum bids are invited upon the several items and quantities of work as follows:

### **Item 1. PICKLEBALL COURTS**

Installation of (2) regulation pickleball courts, including the necessary demolition, earthwork, drainage, 570 square yards of concrete/asphalt paving, perimeter fencing, acrylic coatings, netting, and site restoration.

### Item 2. POURED-IN-PLACE RUBBERIZED PLAYGROUND SURFACING

Removal of approximately 3,620 square feet of existing fiber wood playground mulch and subgrade/base preparation for the installation of a poured-in-place rubberized playground surface around an existing park playground structure.

## Item 3. NATIVE BIO-SWALE AND LANDSCAPE

All earthwork for the preparation of a bio-swale infiltration zone and approximately 300 square yard planting bed area, including the installation of native plant materials, for the purpose of infiltration of stormwater and improving water quality.

Contract Documents, including Drawings and Technical Specifications, shall be downloaded from the Michigan Intergovernmental Trade Network (MITN), <a href="www.bidnet.com">www.bidnet.com</a> on or after Thursday, August 1, 2024.

A non-mandatory Pre-bid Meeting will be held on **Tuesday, August 13, 2024, @ 10:00am**, located at Briley Township Park Pavilion, 11238 Parland Street, Atlanta, MI, 49709. All questions must be submitted in writing by 4:00pm, Tuesday, August 20, 2024, to <a href="mailto:deputyclerk@brileytownshipmi.gov">deputyclerk@brileytownshipmi.gov</a>. All addendums will be issued through MITN.

A certified check or bank draft, payable to the order of *THE TOWNSHIP OF BRILEY*, negotiable U.S. Government bonds (at par value) or a satisfactory Bid Bond executed by the Bidder and an acceptable surety in an amount equal to five percent (5%) of the total Bid shall be submitted with each Bid.

Attention is called to the fact that not less than the minimum salaries and wages as set forth in the Contract Documents must be paid on this project, and that the Contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex, or national origin.

The TOWNSHIP OF BRILEY reserves the right to reject any or all Bids or to waive any informality in the bidding.

Bids may be held by the *TOWNSHIP OF BRILEY* for a period not to exceed NINETY (90) days from the date of the opening of Bids for the purpose of reviewing the Bids and investigating the qualifications of Bidders, prior to awarding of the Contract.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.

The successful bidder will be required to furnish satisfactory Performance, Labor and Material, and Maintenance and Guarantee Bonds.

A firm fixed-price contract award will be made in writing to the lowest responsive and responsible bidder.
