ADVERTISEMENT FOR BIDS 2025 WATER MAIN IMPROVEMENTS PROJECT ROYAL OAK TOWNSHIP OAKLAND COUNTY, MICHIGAN

Sealed proposals for the construction of the **Royal Oak Township 2025 Water Main Improvements** project will be received at the Township Office, 21131 Gardenlane, 2nd Floor, Ferndale, MI until **10:00AM Local Time on December 11, 2024**, at which time and place all bids will be publicly opened and read aloud.

Bidders shall review and comply with the Instructions to Bidders, which are incorporated by reference, and carefully review all Contract Documents, as defined in the Instructions to Bidders. Bids submitted after the exact time specified for, receipt will not be considered.

The Contracts will consist of the following principal items of work and appurtenances as specified herein and shown on the Contract Drawings.

Installing new 12" HDPE DIPS DR11 pipe using the horizontal direction drilling method along the north side of the 8 Mile Right-of-Way between the back of curb and property lines from Mendota Ave. to approximately 650' east of Wyoming Ave and installing new 8" HDPE DIPS DR11 along Mendota Ave. from Eight Mile Road to Fitzgerald Pl., Pasadena Ave. from Mendota Ave. to Ithaca Ave., Fitzgerald Pl. from Mendota to Evers Pl., and Woodside Ave from Northend Ave. to 250' south of Pasadena Ave. Project consists of curedin-place pipe lining along Glen Lodge Avenue from the south dead end to Bates Street.

Total quantities of new water main installed for this project are 6,155 feet of 8" diameter pipe by horizontal directional drilling, 1,081 feet of 8" diameter pipe by open cutting, 1,710 feet of 12" diameter pipe by horizontal directional drilling and 203 feet of 12" diameter pipe by open cutting. Total quantity of 8" diameter water main cured-in-placed pipe lined is 1,579 feet.

No inquiry received less than seven (7) days prior to the date fixed for the opening of Bids will be given consideration.

Addenda issued to Bidders prior to the date of receipt of proposals shall become a part of the Procurement Documents and all proposals shall include the work described in each and every Addenda issued. <u>Addenda</u> will only be made available through the BidNet Direct/MITN website. It is the responsibility of the Prospective Bidder to check this website prior to the bid submission deadline to ensure all addenda issued have been acknowledged.

Please note that Prime Contractors bidding on this project must follow, document, and maintain documentation of their Good Faith Efforts (GFE), to ensure that Disadvantaged Business Enterprises (DBEs) have the opportunity to participate in the project by increasing DBE awareness of procurement efforts and outreach. In addition, Labor Standards Provisions for Federally Assisted Projects, including Davis-Bacon Act compliance, must be adhered to. Lastly, applicable materials for this project must meet the "Build America, Buy America" requirements of federally funded projects.

Proposals submitted by Bidders who have been debarred, suspended, or made ineligible by any Federal Agency will be rejected.

Each bidder agrees to waive any claim it has or may have against the Owner, the Architect/Engineer, and their respective employees, arising out of or in connection with the administration, evaluation, or recommendation of any bid.

Each bid proposal shall be submitted on the proposal forms provided and shall be accompanied by a certified check, cashier's check or bid bond, executed by the bidder and Surety Company, payable to Royal Oak Township in the amount of Five Percent (5%) of the accompanying bid. Proposal Guarantee shall provide assurance that the bidder will, upon acceptance of the bid, execute the necessary Contract with Royal Oak Township.

All bids shall be opened publicly at the date and time specified. Each bid shall be recorded together with the name of the bidder. Bids shall be in accordance with the requirements of this notice in order to be deemed "responsive."

Bids are to be submitted in a sealed envelope, plainly marked "BID – Royal Oak Township 2025 Water Main Improvements" and received by the Township Clerk on or before the time and date given above.

No bid may be withdrawn after scheduled closing time for receiving bids for at least one hundred twenty (120) calendar days. The right to accept any bid, to reject any or all proposals and to waive irregularities in bidding is reserved by Royal Oak Township. Portions of this Contract may be deleted due to unforeseen circumstances without compensation. Acceptance of any bid does not constitute a binding agreement until a written Contract is signed by both parties.

The successful bidder will be required to furnish satisfactory Performance, Labor and Material, and Maintenance and Guarantee Bonds.
